3. Exhibitors have the right to cancel this agreement by written notice to NCPDP. Exhibitors cancelling space prior to November 24, 2017 will receive a 50% refund, less \$100 administrative processing fee. NO REFUNDS will be made on spaces cancelled after November 24, 2017.
4. CSI is the official show decorator of the NCPDP 2018 Annual Technology & Business Conference. A representative from CSI will be in contact with the person(s) designated above. Exhibitors must adhere to the rules contained in the Service Manual regarding set-up, tear down, exhibit space, etc.
