

ASC X12N's Public Comment Period Timeline for 7030™ Technical Reports

ASC X12's Insurance Subcommittee (X12N) released a revised schedule of planned public review and comment periods for the 7030 counterparts to the HIPAA-adopted transactions and related Type 3 Technical Reports (TR3s).

The following cycles accommodate 60-90 days of public review for each release set and allow for all review periods to be complete by the middle of 2017. The TR3s associated with HIPAA covered transactions are denoted with an asterisk.

Input from implementers is critical to successful rollout of these transactions. ASC X12 encourages implementers to review and comment on the TR3s during this process so that any concerns or issues can be addressed in a timely and effective manner.
