3. Exhibitors have the right to cancel this agreement by written notice to NCPDP. Exhibitors canceling space, prior to January 13, 2023, will receive a 50% refund less \$100 administrative processing fee. NO REFUNDS will be made on spaces canceled after January 13, 2023.
4. Exhibitors will NOT be recognized on the conference website or printed materials until full payment is received.
5. CS+I is the official show decorator of the NCPDP 2023 Annual Technology & Business Conference. A CS+I representative will be in contact with the person(s) designated above. Exhibitors must adhere to the rules contained in the Service Manual regarding set-up, tear down, exhibit space, etc.
