The annual event showcased NCPDP’s milestone achievements over the past 40 years – improving the healthcare experience for patients and providers; improving administrative efficiencies and access to clinical data with its ANSI-accredited industry standards; and the positive impact of NCPDP’s best practices industry guidance.

The conference opened with a 40th Anniversary Champagne Brunch. During the conference, Stember announced the ONC’s (Office of the National Coordinator for Health IT) interest in helping to fast-track a mandate for SCRIPT 2016071, the newest version of NCPDP’s SCRIPT ePrescribing Standard. She also discussed NCPDP’s EDvocracy initiative, its next level strategic planning process, and how NCPDP is creating a path to leadership for emerging professionals.
